Subject: CX/KA Fuel Surcharge (Effective Jan 01, 2012)

Please be advised that CX/KA Fuel Surcharge will be revised as follow, AND PLEASE NOTE the amounts listed below are ABOSOLUTE CHARGES (do not ADD this amount to current fuel charges, amount shown IS the new FUEL SURCHARGE):

1. The surcharge will be effective for ticket issue/reissue **on/after January 01, 2012.**
2. The fuel surcharge will be **adjusted** from USD129.20 to **USD137.80** for CX/KA flight coupons between **HKG and South West Pacific, North America, Europe, Middle East, Africa, South Asian Sub-Continent (including KTM/DAC/MAA).**
Please note: HKG-BLR v.v., HKG-KTM v.v., HKG-DAC v.v. and HKG-MAA v.v. will be classified as Long Haul also, so the fuel surcharge will be USD137.80 one way.
3. And from USD 26.90 to **USD29.00** for CX/KA flight coupons NOT mentioned in #2.
Please note: BKK-DXB v.v. will be classified as Short Haul, so the fuel surcharge will be USD29.00 one way.
4. The surcharges apply per passenger per CX/KA flight coupon and will be collected from all passengers regardless of ticket stock except:
 - a) Codeshare flights within France (Ground Transportation),
 - b) CX flights between DMM and BAH (Ground Transportation).
5. This applies to all fare type and regardless of class of travel and type of fares including frequent flyer program.
6. Just a friendly reminder, effective Apr 11, 2011, long haul fuel surcharge will apply for journey involving:
HKG-X/BKK-CMB V.V.
HKG-X/BKK-BOM V.V.
HKG-X/BKK-DEL V.V.
HKG-X/BKK-KHI V.V.
HKG-X/SIN-CMB V.V.
Note: PAX have same day transit (24 hours) in BKK or SIN including same flight number.
7. The surcharge is to be collected at point of sale or ticket issue/reissue and show as // YR // in the TAX/FEES/CHARGES box of ticket.
8. There is no exemption to any category of passengers. (such as children/infants/senior/ID/AD/FOC...ETC.)
9. The surcharge is interlinable and the amount shall accrue to CX/KA.
